Privacy/Age Policy

This privacy pledge discloses how T&J Publishers, Inc. handles personal information collected by T&J Publishers, which includes full compliance with all general data protection regulations. Any user outside of the United States hereby verifies that they are 18 years of age or older and freely gives specific, informed and unambiguous indication that he or she, by completing our order forms, subscription forms and consultation forms, signifies agreement to the processing of personal data relating to him or her as outlined below. Persons within the United States may be 13-17 years of age provided they have the permission of their legal guardian; otherwise over the age of 18.

Personal information is information like your name, address, email address, or phone number (like, for instance, ours is [888-672-6657](tel:888-672-6657)), as well as additional information that is not otherwise publicly available.

T&J Publishers may collect personal information when you complete our order form, when you click on a Pay-per-Click ad paid for by T&J Publishers, or when you participate in the publishing process through the T&J Publishers website.

T&J Publishers collects information about your transactions with us through your use of the services that we offer. We do not purchase any personal data from other companies nor do we profile the personal data you provide to us. If you wish to withdraw your consent, it is your responsibility to do so and you can unsubscribe at any time from the emails being provided to you by clicking on the "unsubscribe" link at the bottom of every email. You must also cease using this website. If you have not made any purchase from T&J Publishers, you may email Info@TandJPublishers.com at any time to request that we delete your data if you wish to have your data removed and no longer wish to access the T&J Publishers website.

Our website host automatically receives and records information on our server logs from your browser, including your IP address, browser settings, and pages requested. T&J Publishers also writes a cookie to your computer. A cookie is a small text file that is stored on a user's computer. T&J Publishers will write and access T&J Publishers cookies on your computer to facilitate your log-in process or to track your affiliate referrals. The information linked by the cookie is only your user ID number. We do not link to or store any other personally identifiable information to the cookie. We use both session ID cookies (for the shopping cart) and persistent cookies. You can manually delete cookies at any time by following the directions given in your Internet browser's Help file. Server logs from your browser, including your IP address, browser settings, and page requests may be kept through perpetuity, however we only use this specific type of personal information to facilitate your experience on our website.

Outside of the exceptions above T&J Publishers uses personal information to:

- * fulfill your requests for products and services
- * contact you
- * offer author support either via the Author Services (pre-publication) support program or the Marketing COACH (post-publication) support program. As a registered participant of this program, T&J Publishers may send e-mails containing publishing or promotion information geared toward helping you make decisions regarding publication and marketing.

When you begin the publishing process with your deposit or full package fee, we will ask for your full name, billing address, and phone number. We will also ask for payment information (credit card number) and your billing address. This information is securely processed through PayPal secure certification for your protection.

We never keep your credit card information on file or stored online. Every time you purchase, you will need to re-enter your credit card number. This is for your protection and security. Additionally, when you order books, we will request your delivery address for the purposes of calculating your shipping fees and for the purposes of delivering your order.

We limit employee and contractor access to your personal information. For example, only the accounting department has access to your tax information.

If you include any personal information in content that you save to your author webpage or include in your book, that information may be widely available to other users. T&J Publishers does not

exercise control over those users and cannot guarantee that your personal information will be protected as described in this Privacy Policy. T&J Publishers does not delete or edit your personal information from the body of your publications. In order to lodge a complaint with a supervisory authority, you may find T&J Publishers a member in excellent standing with the Better Business Bureau at www.bbb.org.

Outside of what is described above, T&J Publishers does not share your personal information with other people or nonaffiliated companies nor to any third country or international organization, although we may need to disclose your personal information in response to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims, or as otherwise required by law. Additionally, we may need to disclose your personal information if we believe it is necessary in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, or violations of our production and distribution agreement. Lastly, we would need to share your personal information in the event T&J Publishers is acquired by or merged with another company.
